ORDINANCE NO. 2008-5

AN ORDINANCE AMENDING APPROPRIATION ORDINANCE 2007-12 TO ADJUST THE CITY OF BELLBROOK APPROPRIATIONS TO REFLECT ADDITIONAL COSTS IN SOME LINE ITEMS AND REDUCED COSTS IN OTHERS.

WHEREAS, the City of Bellbrook has always adopted budgets which reflect a very conservative approach; and

WHEREAS, additional costs have or will occur in some line items and reduced costs are projected in other line items which requires the amendment of various appropriation levels.
