April 23, 2023 – 0135 hours

Officers responded with the medics to Marcia Drive on the report of an unresponsive subject. The subject was transported to MVS for further medical treatment.

April 23, 2023 – 0333 hours

Officers were dispatched to Streamview Court on a suspicious person at the callers front door. When officers arrived, they located the subject, who was intoxicated and attempting to enter the wrong residence. The individual was charged with disorderly conduct by public intoxication and released to a responsible party.

April 23, 2023 – 0333 hours

While investigating a separate offense, officers discovered a hit and run crash on Streamview Court involving a single vehicle and a street sign. Officers were able to locate the driver of the vehicle.

April 23, 2023 – 1252 hours

A peace officer standby was requested on Marcia Drive.

April 23, 2023 – 1648 hours

A peace officer standby was requested on Shadowleaf Drive for a property exchange.

April 23, 2023 – 2147 hours

Officers responded to a business on State Route 725 for a harassment complaint. Unknown subjects in an unknown vehicle yelled at the complainant earlier in the day.

Officers initiated a traffic stop on E. Franklin Street for expired registration. After identifying the driver, it was discovered he was also driving under suspension. A small amount of marijuana was also located in the vehicle. The driver was cited for DUS and expired registration.

Officers responded to Dane Lane on a dog at large complaint. Officers were able to locate the owners and issued a written warning for the dog being loose.

A suspicious person was reported on W. Maple Street. The complainant advised the subject was knocking on his front and back doors. Officers located the individual and he was trespassed from the property at the request of the homeowner.
