September 17, 2023 – 0929 hours

Officers responded to Knob Hill Dr. on a criminal damaging report. Unknown subjects defaced the callers garage door with spray paint sometime overnight.

September 17, 2023 – 1019 hours

While on patrol, officers noticed a stop sign had been spray painted on Mission Lane at Tampico Trail. The service department was notified of the damage.

September 17, 2023 – 1047 hours

Officers responded to Maple Leaf Court on a found property complaint. A rear view mirror and camera were found in the roadway. Officers were able to link the property to a vehicle that was stolen in another jurisdiction.

September 17, 2023 – 2130 hours

Officers were dispatched Ryder Court on a vehicle that crashed into a fire hydrant and left the scene. Officers were able to locate the vehicle and identify the driver. One person was cited for OVI and failure to control.

September 18, 2023 – 0831 hours

Officers were dispatched to Knob Hill Drive on an auto theft. Sometime overnight, unknown subjects stole the complainants vehicle. The vehicle was later recovered by Trotwood Police and the investigation is ongoing.

September 19, 2023 – 0001 hours

A telephone harassment complaint was reported on Bellemeade Drive. No charges at this time.

September 19, 2023 – 0856 hours

Officers assisted with a private property crash on Upper Bellbrook Road. The drivers exchanged information and no one was cited.



September 19, 2023 – 1721 hours

Officers were dispatched to W. Franklin Street for a traffic crash. A vehicle traveling east became distracted, crossed the center line and crashed into a parked car. Officers did locate an open can of beer in the vehicle, but the driver passed all sobriety tests. The driver was cited for the open container and failure to control. No injuries were reported.

September 19, 2023 – 2132 hours

Officers were dispatched to Portage Path on a suspicious circumstances complaint. The caller stated that a screen was removed from their window. Unknown time frame. The window was locked and there were no signs of entry or damage.

September 20, 2023 – 1520 hours

Officers assisted the medics on Ryder Court.

September 20, 2023 – 1733 hours

Officers responded to E. Maple Street on a child custody dispute. The parties were advised that this is a Civil matter.

September 20, 2023 – 1925 hours

Officers were dispatched to W. Maple Street on an unwanted subject. The complainant did not want to pursue a trespassing order, but officers advised the subject to leave the callers property. The subject left without incident.

A suspicious person was reported on Vemco Drive. Officers searched the area but were unable to locate.



September 21, 2023 – 0153 hours

Officers conducted a traffic stop on W. Franklin Street for a red-light violation. Further investigation revealed the passenger was wanted on active warrants out of GCSO and the driver was Driving Under Suspension.

September 21, 2023 – 1154 hours

Officers assisted with a private property crash at a business on W. Franklin Street. The drivers exchanged information and no citations were issued.

September 21, 2023 – 1721 hours

Officers assisted the Medics on Kensington Drive.

September 21, 2023 – 2015 hours

A welfare check was requested on Bledsoe Drive after screaming was heard. Officers located the individual and determined they were searching for their cat. No cause for complaint.

September 22, 2023 – 0604 hours

Officers responded to Wilmington Dayton Road on a single vehicle crash. No injuries were reported.
