NARRATIVE

Unit 1 was traveling eastbound on SR 725. According to witness, Unit 1 drove around in a circle. Unit 1 acted like it was going to turn right (southbound) on two separate occasions, but continued east. Unit 1 was driving slow and it veered off the south side of the roadway at S. Lakeman Dr.

Unit 1 was traveling eastbound where it veered off the roadway (.south side) just east of Mill Pond Dr. Unit 1 returned to the roadway continuing eastbound. Unit 1 again veered off the roadway at S. Lakeman on the south side of the roadway. Unit 1 struck a crosswalk sign near the southeast corner of S. Lakeman and w. Franklin. Unit 1 continued eastbound in the ditch almost striking two utility poles. Unit 1 came to a stop in the southern ditch just west of Bonnedale Dr.

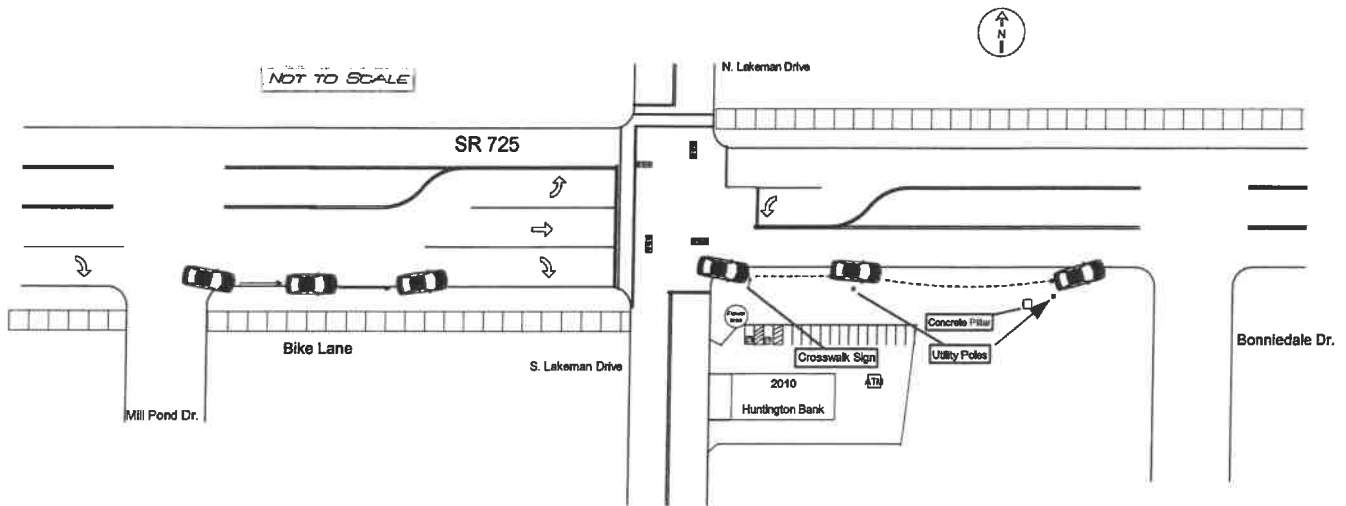

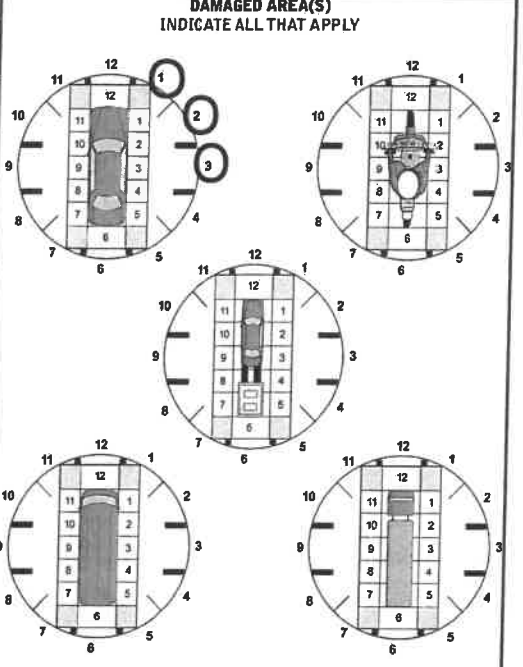

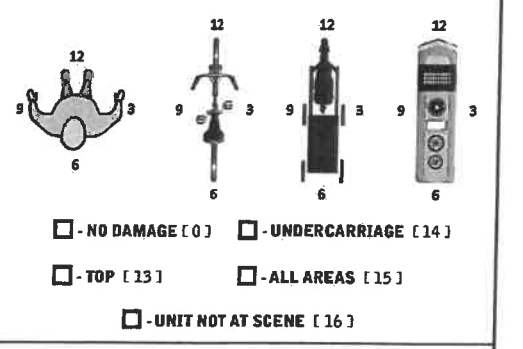
