Unit #2 was facing southbound on Washington Mill Rd. at E. Franklin St. at the posted stop sign and stop bar. Unit #2 slowly moved forward to check clearance to turn westbound onto E. Franklin St.

Unit #1 was traveling eastbound on E. Franklin St. Unit #1 was hauling a trailer with lawn mower equipment. Unit #1 started to turn northbound onto Washington Mill Rd. Due to the trailer, Unit #1's trailer was actually shortcutting the turn.


Unit #1's trailer driver side axle struck Unit #2 driver side front bumper/headlight assembly popping off the cover of Unit #2 and scratching bumper.

Both parties exchanged information and were referred to their insurance companies.
