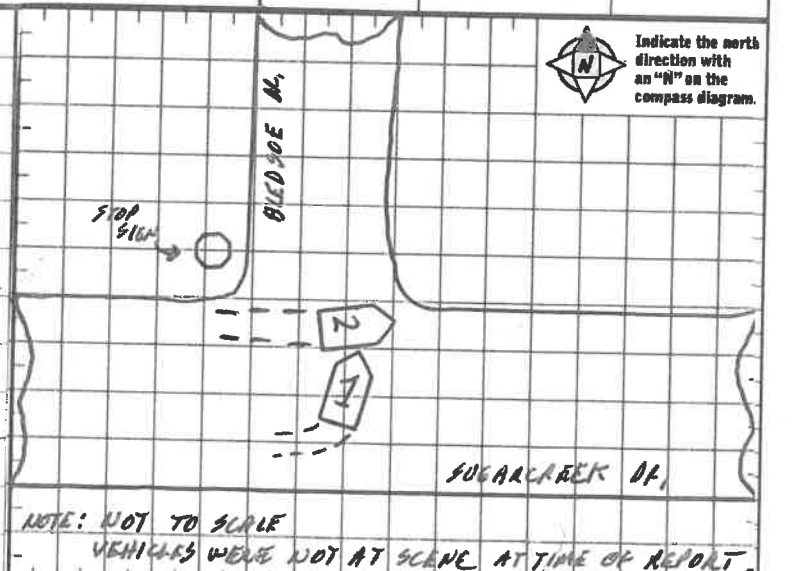

NARRATIVE

On 02/22/2021, Unit #1 (Oh reg. FRE4889) was traveling South on Bledsoe. As Unit #1 came to a stop at the intersection of Sugarcreek Dr., Unit#1 driver observed only one vehicle West of his position (Unit#2 OH reg. HRZ5431) just turned Eastbound onto Sugarcreek Dr. from North Lakeman). Unit #1 driver felt that there was plenty of distance for a safe U-Turn in the intersection. Unit #1 proceeded with an U-Turn. As Unit#1 was facing North on Sugarcreek to proceed onto Bledsoe, Unit #2 traveled into the Westbound lane of Sugarcreek to go around Unit#1. Note: Unit #2 driver stated that he did not come to a full stop but continued to pass Unit #1 at around 15 MPH. Unit#2 made contact with Unit#1's front left corner of the vehicle. Unit#2 driver stopped and advised Unit#1 driver that he was in a hurry and only gave him a first name of Brian and a cellphone #. Unit#2 then left the scene.

Unit#1 driver came to the Bellbrook Police station and reported this accident. Body Cam active.



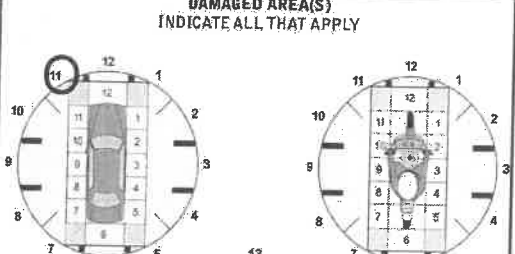
