Unit #1 was traveling eastbound on W. Franklin St. and was in front of Unit #2.

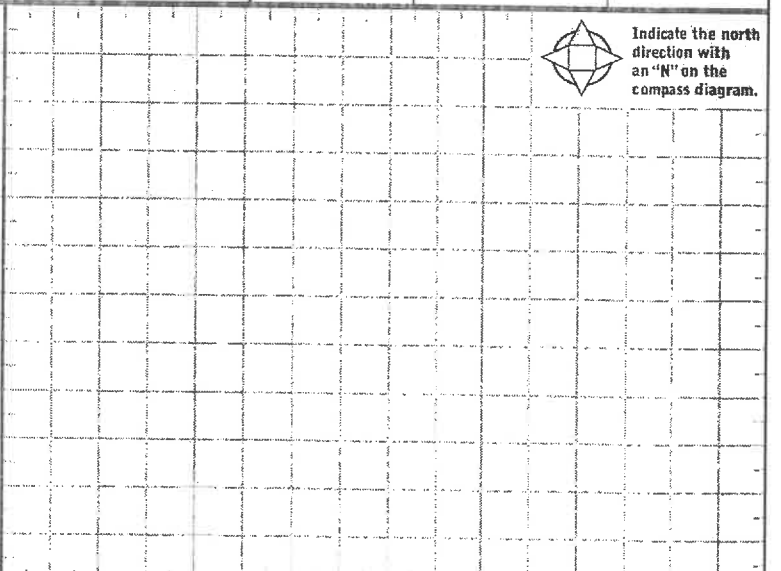
Unit #1 entered the turn lane (northbound) for N. Bellview Dr.

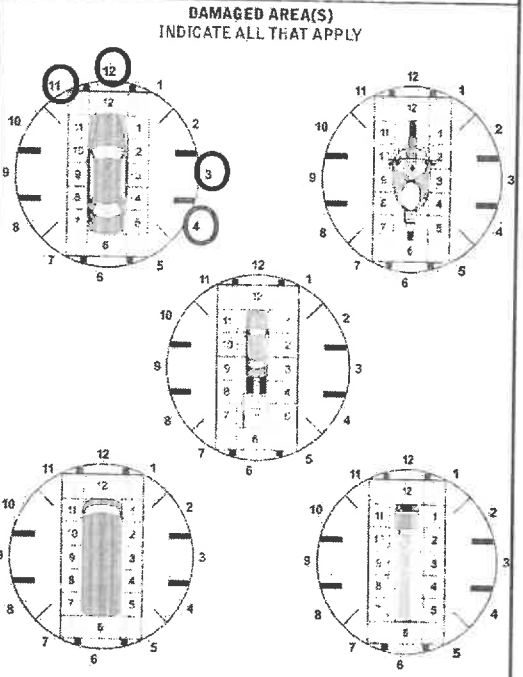
