**April 10, 2022 – 1718 hours**

Officers responded with the Medics to Woodedge Drive on an unresponsive subject. The individual was deceased upon arrival. No foul play is suspected at this time.

**April 11, 2022 – 0521 hours**

Officers were dispatched to Mill Pond Drive on a domestic dispute. It was determined that the dispute was verbal only and no threats had been made.

**April 11, 2022 – 1000 hours**

A fraud complaint was reported on E. Carmella Court. Unknown subjects attempted to open a credit account in the complainants name.

**April 12, 2022 – 0820 hours**

Officers responded to Wentworth Village Drive on a residential alarm. Confirmed FA.

**April 12, 2022 – 1534 hours**

Officers were dispatched to Tampico Drive on an animal problem. Due to repeated violations involving “dogs at large”, officers requested assistance from Greene County Animal Control.

**April 12, 2022 – 1658 hours**

Officers were dispatched to a traffic crash on West Franklin Street. No injuries were reported and one driver was cited for ACDA.

**April 13, 2022 – 1223 hours**

Officers responded to Wilmington-Dayton Rd. to assist a motorist with a disabled vehicle. They were able to safely move the vehicle from the roadway.

**April 13, 2022 – 1630 hours**

Officers spoke with a resident on Poston Dr. regarding an unemployment fraud complaint.



**April 13, 2022 – 1832 hours**

Telecommunications harassment was reported on Shadowleaf Dr. Unknown subjects were threatening the complainant over social media. Complainant declined to press charges.

**April 13, 2022 – 1918 hours**

Officers responded with the medics to Plantation Trail. One individual was taken to MVS for further treatment.

**April 14, 2022 – 0149 hours**

Officers conducted a traffic stop on Wilmington Dayton Rd after observing the vehicle traveling left of center several times. Further investigation revealed that the driver was intoxicated. The driver was charged with OVI and transported to the Greene County Jail.

**April 14, 2022 – 0938 hours**

Officers responded to E. South Street on a disorderly person complaint. The subject became increasingly agitated and combative. Charges are pending.

**April 14, 2022 – 1513 hours**

Theft was reported on Washington Mill Road. Unknown subjects stole the catalytic converter from an RV sometime over the winter months. Unknown suspects at this time.

**April 14, 2022 – 1744 hours**

A suspicious person was reported on N. West Street. An unknown person was sitting in the callers yard. Officers located the individual who stated they were waiting for a taxi. The subject moved off of private property without incident.

**April 15, 2022 – 0030 hours**

A resident on Maxwell Drive reported that a known subject had been driving their vehicle without their consent since March. Officers contacted the other party and located the vehicle. No charges filed.



**April 15, 2022 – 1116 hours**

Officers were dispatched to Belleview Drive for a welfare check. The caller witnessed a van believed to be following a pedestrian. Further investigation revealed the driver and pedestrian were related and there was no cause for concern. Everyone checked OK.

**April 15, 2022 – 1133 hours**

A suspicious person was reported on North Main Street. The subject was looking in business windows and appeared to be acting suspiciously. The subject was identified by Police and left the area.

**April 15, 2022 – 1610 hours**

Officers were dispatched to Post to speak with a resident regarding a fraud complaint. Unknown subjects opened a credit card account in the complainants name and charged less than \$500 to the account. The investigation is ongoing.

**April 16, 2022 – 0207 hours**

A suspicious vehicle was reported on Shadowleaf Drive. Officers made contact with the driver who stated he was there to pick up a friend. No cause for complaint.

**April 16, 2022 – 1601 hours**

A welfare check was requested on Beechwood Drive. Officers were unable to make contact with the resident. The perimeter checked secure and officers saw no signs of distress. Officers attempted to contact via telephone.

**April 16, 2022 – 1723 hours**

Trespassers were reported on Upper Bellbrook Road. The caller reported several subjects were using the schools batting cages without permission. The subjects left without incident.
