**March 26, 2023 – 2126 hours**

Officers initiated a traffic stop on W. Franklin Street after observing a vehicle with a brake light violation. Officers identified the driver and discovered that they were driving under suspension and had an active felony warrant out of Butler County. Further investigation revealed the possession of crack cocaine and drug paraphernalia. Officers cited the driver and transported them to the Greene County Jail to await pickup from Butler County.

**March 27, 2023 – 1142 hours**

Officers assisted STPD in locating a suspect that fled from them on foot after leaving their vehicle on Upper Bellbrook Road. The subject was subsequently apprehended on Catalpa View Drive.

**March 29, 2023 – 0014 hours**

Officers were dispatched to W. Franklin Street on a barking dog complaint. The owner was issued a written warning.

**March 29, 2023 – 0222 hours**

Officers were dispatched to Wilmington-Dayton Road for an injury crash involving a single vehicle and a tree. Officers located the driver outside the vehicle. Medics transported the driver to MVS for medical attention. Alcohol is believed to be a factor in this crash. In addition to the crash, the driver was cited for OVI, open container and a seat belt violation.

**March 29, 2023 – 2304 hours**

Officers observed a suspicious vehicle on North Regent Park Drive. After observing an erratic driving pattern, officers made contact with the driver, who stated that he was lost.

**March 30, 2023 – 0047 hours**

Officers responded to Upper Hillside Drive on a noise complaint involving juveniles yelling. Officers located the juveniles and spoke with the parents regarding the complaint.



**March 30, 2023 – 1854 hours**

Officers assisted the medics with a female that had fallen and was unconscious at a business on W. Franklin Street. Upon arrival, the subject was awake and talking. Medics transported the patient to MVS for further evaluation.

**March 30, 2023 – 2039 hours**

Officers were dispatched to a traffic accident involving a single vehicle and a deer strike on Wilmington-Dayton Road. No injuries reported.
