#### April 2, 2023 - 0106 hours

Officers initiated a traffic stop for speed on Wilmington-Dayton Road. After speaking with the driver, Officers detected a strong odor of alcohol. The driver was cited for OVI and weapons while intoxicated after officers discovered a gun in the vehicle. They were released to a responsible party.

#### April 2, 2023 – 1832 hours

Officers responded to W. Maple Street on the report of a loose dog. Upon officers arrival, the dog was inside the house. The resident was given a verbal warning.

### April 3, 2023 – 1313 hours

Identity theft was reported on Polo Trace Court. Unknown subjects opened a credit card in the complainants name.

# April 3, 2023 - 1915 hours

Officers were dispatched to Beryl Drive on a suspicious person in the complainants yard. Officers located the subject, who indicated that they had lost their drone in the area. No criminal activity suspected.

A welfare check was requested on Beechwood Drive. The resident checked ok.



#### **April 5, 2023 – 1319 hours**

Officers assisted with a vehicle lockout at a business on W. Franklin Street. Entry gained.

#### **April 5, 2023 – 1912 hours**

Officers were dispatched to Old English Circle on the report of a resident with a charcoal grill on their deck. The resident extinguished the coals without incident upon officers arrival.

### **April 6, 2023 – 0013 hours**

Officers responded to Woodedge Drive on the report of a fight in progress. Officers were unable to locate a fight or disturbance, and after speaking with neighbors, determined that none of the reported circumstances had taken place. Officers spoke with the complainant to check their welfare, and determined they may be suffering from a medical condition. One person was transferred to MVS for evaluation.

# **April 6, 2023 – 1324 hours**

Officers were dispatched to Post to meet with a complainant regarding a fraud report that occurred on Kensington Dr. Unknown subjects were able to defraud the complainant over the telephone. The investigation is ongoing.

# **April 6, 2023 – 1623 hours**

Officers responded to a traffic crash on W. Main Street. One vehicle was stopped at the traffic light and was hit by another vehicle. No injuries were reported and one driver was cited for ACDA.

# April 7, 2023 – 0948 hours

Officers were dispatched W. Franklin Street on the report of a domestic dispute. After speaking with everyone involved, it was determined that the argument was verbal only, and no threats had been made. The parties agreed to separate for the day.



### **April 8, 2023 – 0015 hours**

Officers responded to Wilmington Dayton Road on a crash involving a vehicle and a mailbox. The driver was not on the scene. Officers were later able to contact the driver and he was cited for Failure to Control.

# **April 8, 2023 – 1505 hours**

A possible dispute was reported on Knoll Drive. When officers arrived, they learned that the parties were verbally arguing over a cell phone. It was determined no threats or violence had occurred. The cell phone was returned to the owner without incident and officers cleared the scene.
