Officers spoke with a resident on Barnett Drive regarding a possible harassment complaint. The resident had questions only, and it was determined no criminal activity had occurred.

July 30, 2023 – 2233 hours

Officers were dispatched to Sugar Run Trail on a missing juvenile. The juvenile was quickly located and returned home safely.

July 31, 2023 – 1423 hours

Officers responded to Lakeview Drive for a neighbor dispute. One subject was issued a trespass warning and advised not to return.

July 31, 2023 – 1506 hours

A parking complaint was received for a U-Haul trailer blocking part of the roadway on Lakeview Drive. Officers made contact with the resident, who agreed to move the trailer to the driveway.

July 31, 2023 – 1749 hours

A soliciting complaint was reported on Big Tree Rd. Officers located the individual and advised him that he needed to obtain a solicitors permit. He left the area without incident.

July 31, 2023 – 2056 hours

Officers were dispatched to Cabernet Way on a telecommunications harassment complaint. Officers advised both parties to cease communication with each other. No charges at this time.

August 1, 2023 – 0640 hours

A welfare check was requested on Lakeview Dr. All residents checked OK.



August 1, 2023 – 0659 hours

Officers responded to Bledsoe Drive on a parking complaint involving a boat parked on the street.

August 2, 2023 – 0109 hours

A welfare check was requested on N. Belleview Drive. All residents checked OK.

August 2, 2023 – 1549 hours

Officers responded to Clarkston Drive for a hit-skip accident where a vehicle struck a mailbox and left the scene. Officers were able to locate the vehicle and driver and issued a citation.

August 3, 2023 – 1732 hours

A Peace Officer was requested on Bledsoe Drive. Officers stood by for a child custody exchange.

August 3, 2023 – 1928 hours

Officers responded to a business on E. Franklin Street for a private property accident. Officers stood by while the parties exchanged information.

August 4, 2023 – 0814 hours

Officers were dispatched to W. Franklin Street for a deceased deer in the roadway. Officers called for the service department to remove the animal and stood by for traffic safety.

August 4, 2023 – 1256 hours

Officers responded to Sugar Run Trail for a 9-1-1 hangup. Officers were able to locate the source of the call and verified that it was an accidental dial. No cause for complaint.



August 4, 2023 – 1342 hours

Officers were dispatched to Poston Drive for an unwanted subject. The caller advised that they asked the subject to leave several times. There were no reports of threats or violence, and the subject left without incident upon officers arrival.

August 4, 2023 – 1914 hours

Officers responded to Cedar Court on a trespassing complaint. The resident did not wish to have the subject trespass from the property, but he advised that they could not stay there. Officers assisted the subject with a ride to another location.

August 5, 2023 – 0256 hours

Officers assisted STPD with an OVI traffic stop on Upper Bellbrook Rd.

August 5, 2023 – 1616 hours

Officers responded to Ryder Court on a possible domestic disturbance. The parties were separated upon officers arrival. After speaking with all involved, it was determined the dispute was verbal only.

August 5, 2023 – 2228 hours

Officers responded to Lakeview Drive on a threats complaint. It was determined that one neighbor had threatened another neighbor. While officers were conducting their investigation, the suspect ran inside and refused to comply with officers. The individual was subsequently charged with menacing, inducing panic and obstructing official business.
