September 10, 2023 – 1133 hours

Officers responded to a residential alarm drop on Sable Ridge Dr. Confirmed FA.

September 10, 2023 – 1710 hours

A welfare check was requested on Bellemeade Drive. All residents checked OK.

September 10, 2023 – 2312 hours

While on patrol, officers located a suspicious vehicle in a parking lot on W. Franklin Street. The vehicle was occupied by one subject sleeping in the drivers seat. After waking the subject, officers detected a strong odor of alcohol and also noticed an open bottle of Vodka in the vehicle. The driver was cited for OVI – Physical Control and Having an Open Container in a Motor Vehicle and released to a responsible party.

September 11, 2023 – 0914 hours

Officers were dispatched to Big Tree Road on a residential alarm. Confirmed FA.

September 11, 2023 – 1500 hours

Officers assisted a motorist with a disabled vehicle on W. Franklin Street.

September 11, 2023 – 1607 hours

A Peace Officer was requested on Bellemeade Drive. Officers stood by for a property exchange.

September 11, 2023 – 1721 hours

Officers responded to Lakeman Dr. to assist the medics with a patient that was awake but possibly having a seizure.



September 11, 2023 – 2339 hours

Officers initiated a traffic stop on Washington Mill Rd. after observing a vehicle driving in the center of the road. Upon making contact with the driver, Officers noticed an open 12-pack of alcohol in the back seat. Officers did not suspect the driver was impaired at this time, but the underage driver was cited for underage possession and driving left of center.

September 12, 2023 – 0927 hours

Officers were dispatched to Lakeview Drive for a Peace Officer request. Officers stood by for a property exchange.

September 12, 2023 – 2243 hours

While on patrol, officers located a suspicious vehicle in a parking lot on State Route 725. The vehicle was running with the occupant asleep in the drivers seat. Officers woke the subject and immediately detected a strong odor of alcohol and observed an empty beer can in the center console. One subject was cited for OVI – Physical Control, Open Container and No Operators License and released to a responsible party.

Officers spoke with a resident on Spring Creek Circle regarding a theft report. Unknown subjects fraudulently took money from the complainants bank account. The investigation is ongoing.

Officers were dispatched to Upper Hillside Drive on a Domestic Dispute. The parties were separated upon arrival, and it was determined that no threats or acts of violence occurred.
