#### November 19, 2023 – 0029 hours

Officers assisted the medics on High Street. One patient was transported to MVS for further evaluation.

#### November 19, 2023 – 0710 hours

Officers were dispatched to a noise complaint on Lower Hillside Drive. Officers located the source of the noise and were in the process of attempting to identify them when they were dispatched to a priority call.

## November 19, 2023 – 0715 hours

Officers were dispatched to a business on State Route 725 on the report of a robbery. After speaking with employees, it was discovered that the call was not placed by any employee or patron of the business and was likely placed by the subject on Lower Hillside attempting to elude officers. Officers returned to Upper Hillside Drive and the subject was gone. The investigation is ongoing.
