November 26, 2023 – 1656 hours

Officers responded to Locus Bend Drive on a domestic dispute. After speaking to all parties, it was determined that the dispute was verbal only and no violence or threats occurred.

November 27, 2023 – 1336 hours

Officers were dispatched to McHenry Court on a damaging complaint. Unknown subjects caused intentional damage to the complainants roof.

November 27, 2023 – 1810 hours

A suspicious person was reported on Cedar Court. Officers located the individual, who appeared upset and distraught. The subject was transported to MVS for medical attention.

November 27, 2023 – 2209 hours

A welfare check was requested on N. Sheffield Dr. All residents checked OK.

November 29, 2023 - 1050 hours

Officers were dispatched to a traffic crash on W. Franklin Street. No injuries were reported and one driver was cited for Improper Backing.

Officers assisted STPD in locating a theft suspect on Wilmington Pike.

November 29, 2023 – 2055 hours

Officers were dispatched to W. Franklin Street on a 9-1-1 hang-up call. Officers were able to locate the source of the call and verified that it was an accidental dial and there was no cause for complaint.



November 29, 2023 - 2253 hours

While on patrol, officers located a suspicious vehicle at a business on State Route 725. Upon further investigation, officers learned that the driver had an active arrest warrant out of Warren County. Officers also located a substance believed to be narcotics in the vehicle.

November 30, 2023 – 1739 hours

A Peace Officer was requested on W. Franklin Street. Officers stood by for a child custody exchange.

November 30, 2023 – 2115 hours

Officers responded to a business on State Route 725 for a suspicious person complaint. The subject had left prior to officers arrival, but officers were able to positively identify the individual. At the request of the business owner, the subject was issued a trespass warning.

December 1, 2023 – 1253 hours

Officers were dispatched to Sugar Run Trail on a private property crash. Officers stood by while the parties exchanged information. No injuries were reported.
