December 10, 2023 - 0716 hours

Officers were called to Spring Creek Circle for a damage to vehicle complaint. Sometime overnight, unknown subjects broke the windows on the complainants vehicle. While investigating this incident, officers were made aware of another vehicle that was also broken into on Spring Creek Circle. The investigation is ongoing.

December 10, 2023 – 0810 hours

Officers were dispatched to N. East Street on an alarm. Confirmed FA.

December 10, 2023 - 0752 hours

A welfare check was requested on Ryder Court after a subject made threats and took the complainants vehicle to an unknown location. Officers were able to contact the subject via telephone and the advised they were OK and the vehicle was later returned. No charges requested.
