On Wednesday, November 29, 2023 at 1057 hours I responded to a crash on West Franklin Street at Regent Park Drive. Unit I was backing eastbound on West Franklin Street while Unit II was stopped on West Franklin Street turning southbound onto Regent Park Drive. Unit II was advised to stop by a utility worker while fiber optic cable was on Regent Park Drive. Unit I struck Unit II causing minor damage. Photographs and witness statements were obtained. The driver of Unit I was issued citation 32576 for improper backing ORC 4511.38. My body camera was activated during this incident.

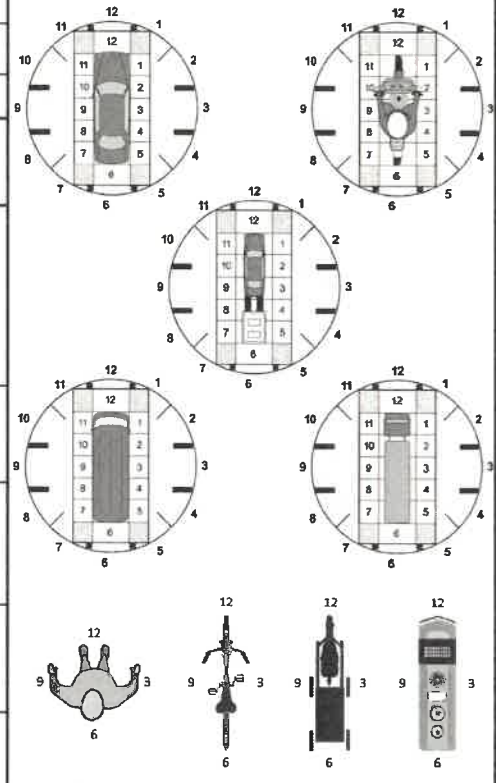
